ADVISEMENT	

You are before the Court because a peace officer for this City has charged you with a violation of the law.

YOU HAVE THE FOLLOWING RIGHTS:

1. To appear before a judge;
2. To be advised by the Court of the nature of the charges against you and of the maximum penalty;
3. To be presumed innocent of the charges, and if you plead not guilty, the prosecution must prove you guilty beyond a reasonable doubt;
4. To bail and to be advised of the amount of bail that has been set by the Court;
5. To make no statement, but that any statement made can and may be used against you;
6. To be represented by counsel, and, if indigent, the right to appointed counsel as applicable;
7. You have a right to a trial by a jury in all cases other than traffic infractions, in which case you have a right to a bench trial (trial to Judge). A written demand for a jury trial must be made in writing within twenty-one (21) calendar days of your entry of your not guilty plea and the written demand shall be accompanied by a jury fee of \$25, unless the fee is waived by the judge because of indigence. If the action is dismissed or you are acquitted of the charge, or if you, having paid the jury fee, file with the court at least seven (7) days before the scheduled trial date a written waiver of the jury trial, the jury fee shall be refunded. Failure to comply with the terms of this paragraph shall be considered a waiver of your jury trial right, and the case will convert to a bench trial;
8. To compel the attendance of witnesses on your behalf by subpoenas, issued by the Court, without expense to you;
9. To testify or not testify in your own behalf. Your silence does not imply any wrongdoing on your part and cannot be used against you;
10. To appeal any judgment within thirty (30) days after the judgment is entered to the district and appellate courts of Colorado; however, if you plead guilty, you waive your right to appeal; and
10. To a continuance of this arraignment, for good cause shown.

NO, I am not currently serving in the U.S Armed Forces and I am not a Veteran.
