## CITY OF SALIDA, COLORADO RESOLUTION NO. 2017-05

A RESOLUTION OF THE CITY COUNCIL OF THE CITY OF SALIDA, COLORADO, APPROVING THE AWARD OF PURCHASING NEW TRUCKS FOR THE 2017 FLEET VEHICLES PROJECT AND AUTHORIZING THE CITY ADMINISTRATOR TO EXECUTE A PURCHASE ORDER BETWEEN THE CITY OF SALIDA AND TOWN & COUNTRY SALIDA.

WHEREAS, The City Council has an approved 2017 budget of \$185,000 for six (6) new fleet vehicles to be purchased for the Fire and Public Works Departments; and

WHEREAS, The City Council has a 2017 budget of \$35,000 to be used for a new vehicle purchase for the Fire Department and approves the purchase of one new ¾ ton Dodge Ram 2500 4x4 for \$29,973.00; and

WHEREAS, The City Council has a 2017 budget of \$25,000 to be used for a new vehicle purchase for the Parks Department and approves the purchase of one new  $\frac{1}{2}$  ton Ford F150 4x4 for \$24,337.56; and

WHEREAS, The City Council has a 2017 budget of \$25,000 to be used for a new vehicle purchase for Wastewater Treatment Plant and approves the purchase of one new  $\frac{1}{2}$  ton Ford F150 4x4 for \$24,015.56; and

WHEREAS, The City Council has a 2017 budget of \$30,000 to be used for a new vehicle purchase for Public Works Streets Department and approves the purchase of one new 1 ton Ford F350 4x4 for \$30,143.12; and

WHEREAS, The City Council has a 2017 budget of \$30,000 to be used for a new vehicle purchase for Public Works Sewer Department and approves the purchase of one new 3/4 ton Ford F250 4x4 for \$30,346.12; and

WHEREAS, The City Council has a 2017 budget of \$40,000 to be used for a new vehicle purchase for Public Works Water Department and approves the purchase of one new 1 ton Ford F350 4x4 for \$34,688.12; and

WHEREAS, the City agrees to pay Town and Country Salida the sum of \$173,503.48 for the 2017 Fleet Vehicles Project according to purchase order dated February 7, 2017.

NOW THEREFORE, BE IT ORDAINED BY THE CITY COUNCIL OF THE CITY OF SALIDA COLORADO, THAT:

- 1. The Salida City Council incorporates the foregoing recitals as its conclusions, facts, determinations, and findings.
  - 2. The purchase order between the City of Salida and **Town and Country Salida**; for the **2017 Fleet Vehicles Project in the amount of \$173,503.48** is hereby approved, and the City Administrator is authorized to sign the purchase order on behalf of the City.
