**A RESOLUTION OF THE CITY COUNCIL FOR THE CITY OF SALIDA, COLORADO  
APPROVING APPOINTMENTS TO THE CHAFFEE HOUSING AUTHORITY BOARD**

**WHEREAS**, the City of Salida Colorado is a statutory city, duly organized and existing under the laws of the State of Colorado; and

**WHEREAS**, in accordance with Section 2-7-10 of the Salida Municipal Code, the City Council shall select and appoint person(s) to serve as members of the City of Salida's boards and commissions; and

**WHEREAS**, on October 6, 2020, the City Council approved Resolution 2020-35, approving an Intergovernmental Agreement (IGA) creating a Multi-Jurisdictional Housing Authority, to be known as the Chaffee Housing Authority, in conjunction with Chaffee County and the Town of Buena Vista; and

**WHEREAS**, the IGA allows for the City Council to appoint two citizens to the Board of Directors of the Chaffee Housing Authority, along with an alternate representative; and

**WHEREAS**, current Board member and City Councilmember Dominique Naccarato, whose term expires on January 1, 2024 is no longer able to serve on the CHA Board; and

**WHEREAS**, the Board seat held by Eileen Rogers expired on January 1, 2023; and

**WHEREAS**, the alternate seat held by Christy Doon expires on January 1, 2024; and

**WHEREAS**, after soliciting and interviewing candidates, the City Council wishes to fill the two City-appointed seats; and

**WHEREAS**, in accordance with Section 2-7-10 of the Salida Municipal Code, the City Council shall confirm the appointments by majority vote.

**NOW, THEREFORE, BE IT RESOLVED BY THE CITY COUNCIL OF THE CITY OF SALIDA, COLORADO THAT:**

**Section 1.** The foregoing recitals are hereby incorporated as conclusions, facts, determinations, and findings of the City Council.

**Section 2.** The Salida City Council hereby appoints Cory "Salty" Riggs as a member of the Board of Directors of the Chaffee Housing Authority, term to expire January 1, 2025.

**Section 3.** The Salida City Council hereby appoints Dan Shore as a member of the Board of Directors of the Chaffee Housing Authority, term to expire January 1, 2026.

**Section 4.** The Salida City Council hereby appoints Christy Doon as an alternate member of the Board of Directors of the Chaffee Housing Authority, term to expire January 1, 2026.

**RESOLVED, APPROVED, AND ADOPTED** this 7 of October, 2023.


