# **PROJECT OVERVIEW:**


The City of Salida Public Art Commission ("**Commission**") is requesting submission of statements of qualifications and proposals from qualified firms, partnerships, corporations, associations, persons, or professional organizations ("Firm(s)") to provide a design concept package for the renovation of a site-specific location in Salida, CO. This request is a formal request for a proposal ("Proposal") by the Commission to contract with any firm responding to this Request for Proposals ("RFP").

The Commission's charge is to oversee public art projects and make recommendations to the Salida City Council. The Commission has elected to embark on a project with the following intentions acting as the guiding principles for the creation of an artistically adventurous space that celebrates the diversity of spirit of the town:

- 1. Landmark
- 2. Visually inviting
- 3. Beautiful yet durable
- 4. Year-round access & use
- 5. Preserving the town's heritage

# **PROJECT LOCATION AND DESCRIPTION:**

The site is in Salida at the corner of US Highway 291 (W 1<sup>st</sup> Street) and G Street at the entrance to the downtown business sector and the Creative Arts District. Currently, the site is designed as and currently used for a recreational skate park, including ramps and bowls traditionally associated with these parks. Additionally, the west side of the current site is bordered by the Monarch Spur Trail, a moderately trafficked but year-round accessible pathway that is steps away from the banks of the Arkansas River. The chosen site is demarked in white on the following image and encompasses approximately 5,578 square feet. If desired, the final design may incorporate existing features of the site.



# PRELIMINARY SCOPE OF SERVICES/ELEMENTS:

The project shall include:

1. A site-specific concept development plan, including preliminary renovation budget, for location at the corner of US Highway 291 (W 1st Street) and G Street

Scope of work shall include:

- 1. Update and review of past meeting and planning documents from the Commission;
- 2. Assessment of community need through community stakeholder and staff meetings;
- 3. Creation of site-specific development plan for the Highway 291 (W 1st Street) and G Street location using a public stakeholder process;

4. Development plan adoption, including preliminary presentation to the Commission by late-September.

All proposals shall include the following:

- 1. A letter of interest, addressing the Scope of Services;
- 2. General statement of understanding of the project;
- 3. Estimated schedule, including all tasks and milestones, for all work necessary to complete the conceptual development plan;
- 4. Summary of qualifications, relevant experience and three references;
- 5. Fee proposal anticipated to include all costs including reimbursables for the services associated with the plan.

\* Successful proposer will be asked to enter into a Professionals Services Agreement with the City of Salida, a copy of which may be obtained from the City of Salida.
